17/049 Matters Arising and Outstanding Issues

17/050 Playing field and Pocket park

Playing Field report - Councillor Bland provided inspection report for April 2017. Councillor Bland reported that there was a party on the field and litter was left. Bin had not been emptied by DDC and Councillor Bland reported this and now resolved.

Play equipment – *Goal posts received* – Goal posts have now been delivered and arrangements to be made for installation. Following discussions it was agreed that Councillor Bland could contact K Wade and ask if he can cement in the goal post stabilizing tubes once pitch has been marked up and fixture location identified

Playing Field gate and bund wall to carpark – Work has been completed

Pocket Park – Amy Hoffman has been undertaking 15 hours of work within the Pocket Park as part of her Duke of Edinburgh Award

Traffic Calming – Clerk to contact Ian Boyes to ask if the size of the sign – Church Brampton to Chapel Brampton can be increased. Also flashing sign approaching Chapel Brampton from Spratton cannot be seen due to a tree obstructing the sign – Clerk to ask Ian Boyes to have this tree cut down. Alternative suggestions have been received from Ian Boyes regarding the island and it was agreed to proceed with these recommendations. Clerk to contact Ian Boyes and to also advise that the understanding was that the work round the island was part of the original plans and part of the funding from Buckton Fields development **Freedom of Information** – Clerk to request a breakdown of costs for the traffic calming works which have taken place in Church and Chapel Brampton

Resident report on heavy goods vehicles through Church Brampton – This is an ongoing problem and Councillor Slinn will talk to Liz Hunt (Speedwatch) to ask if when or after Speedwatch is being undertaken that details of HGV's and the companies are noted.
